


BP "Top Kill" Operation

- "Boot On Neck" (Sec. Salazar)
- "Someone's Ass to Kick" (Pres. Obama)

Regulatory Changes

- Drilling Safety Rule (Adoption of API Standards)
- Moratorium / Slow Permitting
- Workplace Safety Rule (SEMS)
- Cancelled / Suspended Lease Sales

Environmental Changes

- NTL 06 (The "Environmental NTL")
 - Spill Containment / Response Readiness
 - Worst Case Discharge Scenarios
- NEPA Changes / Fewer Categorical Exclusions
- "Enforceable Commitment"

Liability Changes

- Removal / Raising Liability Limits
- Increased Tort Exposure
- Increased Fines / Penalties
- Increased Personal / Criminal Liability



The "New Normal" for Vessel Operations in the GoM

Increased Risk Profile of Oil Companies Will Drive A Flight to Quality for Marine Services:

- "Higher Spec" Vessels (DP-2 & more)
- Demonstrated Culture of Ethics & Safety Will Matter
- Integrity of Vessel Safety Management Systems
- Ability to Attract Quality Mariners
- Increased Coordination of Ship / Shore and Ship / Rig Interface
- Strong Balance Sheet to Support Investment



The "New Normal" for Vessel Operations in the GoM (cont.)

Anemic GoM, if Prolonged, Will Create Challenges When the New Normal Arrives:

- Mariner Shortages Will Intensify
- Shipyard / Shore-based Infrastructure Will Weaken
- New Investment in Vessels Delayed

The "New Normal" for Vessel Operations in the GoM (cont.)

Regulatory Contagion:

- USCG Will Weigh-in With Regulatory Changes of its Own
- Classification Societies Will Review Class Standards and Inspection Processes
- International Regulators Will Heighten Standards
 - International Maritime Organization (IMO)
 - Flag States
 - Port States
