(Any additional materials submitted will be used for illustrative purposes only, and will not be used for judging.)*

### **Institutionalization**

Describe the Culture of Safety model or system used by the organization which has enabled it to achieve its remarkable success. Describe the investment in time, people, money and equipment (if applicable) that is directly responsible for the success. Identify the person, process or implementation technique used to immerse the organization into a culture of safety.

### **Achievement**

Describe how the nomination is a significant safety achievement, rather than simply recognition of a company “doing its job”. Describe in detail, by one or more examples, how your “Culture of Safety” model or system has prevented injury.

### **Documentation**

Provide **5 or more years** of data to support the organization’s outstanding safety performance. The documentation submitted must be presented in a format that meets acceptable interpretative standards to relate such data, such as EHS Performance and TRIR statistics, OSHA reports, near-miss data, stop work actions, etc.

### **Industry Adaptability**

The nominated company (companies) should be an inspiration or example to the entire industry. Please explain the steps taken or elements of this model that could be adopted by other companies or be useful to a wide segment of the industry.
